For the 2017-18 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

* Note TSI and ATS definitions were changed for the 2018-19 school year per federal requirements. The new definitions are:

TSI – The school has at least one subgroup performing in the bottom 25% within each applicable accountability index component.

ATS – The school has met the criteria for TSI identification and has at least one subgroup performing at the same level as a CSI school.

Our school was not given one of these labels.

Improved achievement continues to be our number on priority at Ring Lardner Middle School. We will continue to build on the initiatives highlighted in our 2017-2018 School Improvement Plan. These include continued solidification and implementation of school wide interventions in math and language arts to support at-risk students and provide enrichment opportunities for students not requiring intervention support.

State law requires that we also report additional information.

PUPIL ASSIGNMENT

Students are assigned to a school based on their address. Parents have the option to fill out an intra-district or school-of-choice application in the spring if they wish to attend Ring Lardner.
